



estate mortgages and promissory notes that the Receivership Entities have owned, serviced, or contracted to purchase or acquire (the “Notes”).

2. Through further investigation, the Receiver has discovered that many homeowners have sent payments on the Notes to a post office box in Plano, Texas held in the name of one or more of the Receivership Entities—PO Box 261530, Plano, Texas 75026 (the “Post Office Box”). The Receiver is forwarding all mail received by the Post Office Box and is reviewing it on a daily basis. Included in the mail to the Post Office Box are payments on the Notes totaling, as of today, \$9,709.34 payable to several different entities, including Receivership Entities.<sup>1</sup>

3. At this time, however, several entities that are not Receivership Entities have asserted an interest in many of the Notes. The determination of ownership of the Notes is the subject of the Receiver’s Motion for Show Cause Hearing (Dkt. No. 50). Accordingly, ownership of the funds received at the Post Office Box is uncertain because ownership of the Notes has not yet been determined.

4. As a result, the Receiver requests authorization from the Court to negotiate the funds received at the Post Office Box and hold them in a Receivership bank account until ownership of the Notes is determined and, thus, ownership of the funds.

WHEREFORE, PREMISES CONSIDERED, the Receiver requests an order from the Court authorizing the Receiver to negotiate all funds received at the Post Office Box, regardless of the form or designated payee, and deposit such funds into a Receivership account until such time as the ownership of the Notes on which payment was made is determined, and grant the
