AGREED MOTION TO APPROVE CLAIM DETERMINATION

COMES NOW, Keith M. Aurzada, as receiver in the above-captioned and numbered cause for James G. Temme, Stewardship Fund, LP, and all other entities directly or indirectly controlled by either of them, including but not limited to Stewardship Advisors, LLC d/b/a Stewardship Advisors, LP, Stewardship Asset Management Genpar I, LLC, Stewardship Group, LLC, Destiny Fund, LP, and Stewardship Management, LP (collectively “Receiver” and/or “Receivership Estate” or “Receivership Entities”) and Claimants Bristlewood, LP (“Bristlewood), Stewardship Fund No. 2, LP, Stewardship Fund No. 3, LP, Stewardship Fund No. 4, LP, Stewardship Fund No. 5, LP, Stewardship Fund No. 6, LP, Stewardship Fund No. 7, LP (“Stewardship Fund Limited Partnerships”), Canadian Peso 21, Klipspringer Partners LP, Kennywood Partners, Ltd., J. Christopher Dance, Leslie T. Merrick Investment Trust, The Kenny Allen Troutt Descendants Trust, Canadian Peso 25, and Canadian Peso 27 (“Limited Partnership Members”) (the “Bristlewood Claimants”), and seek approval of the Receiver’s determination with regard to the Bristlewood Claim, respectfully stating:

Introduction

1. Various investors have submitted claims using the form approved by the Court for

investor claims (see Dkts. 41 & 44). The Receiver is accordingly in the process of reviewing claims and determining whether particular claims should be allowed and, if so, what the claim amount should be. Once the claim amounts are determined and approved, the Receiver will seek leave by separate motion to make a distribution of the net assets of the Receivership Estate.

2. This Motion seeks approval of the Receiver's determinations with regard to the allowance and claim amount for certain claims submitted by the Bristlewood Claimants. For the reasons stated, the Receiver believes that his determinations as to this claim should be approved.

Claim at Issue

3. On or about February 27, 2012, the Bristlewood Claimants submitted a claim using the approved Investor Proof of Claim Declaration Form ("Bristlewood Claim"). Together with the form, the Bristlewood Claimants provided a full cash accounting of their investments and returns, as well as various supporting documents with regard to the subject transactions. The Bristlewood Claimants showed that they collectively suffered a net cash loss as of the appointment of the Receiver of \$9,137,715.75.

4. The Receiver has had an opportunity to review the Bristlewood Claim and supporting materials and is of the opinion that the Bristlewood Claimants collectively suffered a net cash loss in the amount stated as a result of the fraud scheme described more specifically in the SEC Complaint herein. The Bristlewood Claimants contend that they were persuaded by Defendant Temme to invest in limited partnerships in which Defendant Temme acted as general partner. They report that, as such, Defendant Temme purported to acquire at a discount "tapes" of distressed, foreclosed upon, or non-performing residential mortgages. They further report that, in fact, in a number of cases, Defendant Temme purchased no tape at all. According to them, in other cases, Defendant Temme purchased a tape, but later sold the tape without

remitting the proceeds to their particular limited partnership as promised. The Receiver has reviewed various materials submitted by the Bristlewood Claimants, including a full accounting, and accepts the proposition that the Bristlewood Claimants were defrauded in a manner comparable to that described by the Commission in its Complaint herein.

5. The Receiver has worked with the Bristlewood Claimants to determine an appropriate loss amount. One issue that the Receiver has struggled with is the question of how to take into account the limited partnership structure that the Bristlewood Claimants who are Limited Partnership Members established with Stewardship Fund, LP acting as the general partner. This struggle has been further exacerbated by the consistent problems associated with ownership/titling of assets. Specifically, many of the assets acquired on behalf of the Bristlewood Claimants remain titled in the name of one or more Receivership Entities. Despite this one fact, the conduct of Mr. Temme, acting through Stewardship Fund, LP, was of the same kind and character as described in the Complaint, and, as a result, the Limited Partnership Members each suffered net cash losses¹, with the only exception being Kennywood Partners, Ltd., which had an overall gain of \$74,954.31. Accordingly, individual equitable claims could be approved, with that one exception, as to those members.

6. Further, since the Limited Partnership Members have attempted to work together to collectively salvage the remains of the venture by contributing their interests in the Stewardship Fund Limited Partnerships to a single entity (Bristlewood), the Receiver could approve a claim in favor of Bristlewood with a slight adjustment for Kennywood Partners, Ltd. On the other hand, the Limited Partnership Members (or, more accurately, Bristlewood) have

¹ For purposes of this claim determination, the Receiver believes it is impractical to analyze the individual operations of the Limited Partnership Members after the date of the Receiver's appointment for purposes of setting off claims. Instead, the Receiver will use a calculation of net cash loss as of the appointment of the Receiver. The Receiver reserves his right to offset other claims for post-receivership conduct outside the ordinary course of business.

attempted to operate the Stewardship Fund Limited Partnerships in cooperation with the Receiver (see, e.g., Dkts. 62 & 63) rather than dissolve the structure entirely. This raises the question of whether the Receiver should, instead, view the claims as being made by each Stewardship Fund Limited Partnership for damages caused by Mr. Temme and Stewardship Fund, LP while acting as the general partner. If the latter course is taken, then conceivably, an offset could be argued by virtue of the fact that one of the Stewardship Fund Limited Partnerships (Stewardship Fund No. 2, LP) had a net gain of \$1,518,599.54.²

Agreed Claim Determination

7. In the interest of avoiding controversy, the Bristlewood Claimants have agreed to take a conservative approach, and accept the Stewardship Fund No. 2, LP gain as an offset, such that its net cash loss will be lowered to \$7,619,116.21. Additionally, the Receivership Estate will continue to have a 40% profits interest as set forth in the relevant limited partnership agreements of Stewardship Fund Nos. 3-7. In the Receiver's judgment, this proposed claim amount reflects the highest conceivable offset that the Receiver could obtain against the claim and maintains an asset of the estate, the limited partnership interests, without the need for litigation.

8. The Receiver and the Bristlewood Claimants have accordingly entered into a stipulated claim agreement, a copy of which is attached as Exhibit 1, and hereby tender the stipulated claim determination for the Court's consideration. The stipulation excludes the matters previously addressed in the Asset Disposition Agreement (see Dkts. 62 & 63) and provides for the Receivership Estate to otherwise retain its interests in the Stewardship Fund Limited Partnerships.

²It is not feasible to recover this amount from Stewardship Fund No. 2, LP because distributions were made to Limited Partnership Members who (other than Kennywood Partners, Ltd.) themselves suffered net cash losses.

Authorities

9. The Court's consideration of the Receiver's determination is entrusted to the Court's sound discretion because the administration of claims made against Receivership Assets is an exercise of the Court's equitable power. *See SEC v. Forex Asset Mgt.*, 242 F.3d 325, 331 (5th Cir. 2001); *US v. Durham*, 86 F.3d 70, 72 (5th Cir. 1996). A claims determination approved by this Court becomes a final judgment as to the petitioning creditor's claim. *Gelberg v. Richardson*, 82 F.2d 314 (9th Cir. 1936); II CLARK ON RECEIVERS § 655, at 1148 (Anderson 3d ed. 1959).

10. As a general rule, where an equity receiver is presented with competing claims to property, the order of priority of payment is (1) administrative expenses; (2) return of third-party property held in trust or otherwise by the defendant; (3) payment of priority government claims; (4) payment of secured parties from secured assets; (5) payment to creditors securing the appointment of the receiver as equity may require; (6) pro rata payment to general creditors; (7) surplus to the defendant for whom the receiver was appointed. III CLARK ON RECEIVERS § 667, at 1198 (Anderson 3d ed. 1959).

11. Applying these principles in securities fraud cases, a number of courts have approved a pro rata distribution of assets to victims of the securities fraud from the proceeds of such fraud based upon their net cash losses. *See, e.g., SEC v. Credit Bancorp, Ltd.*, 290 F.3d 80, 88-89 (2d Cir. 2002) (explaining that each investor claim is a constructive trust claim); *see also SEC v. Forex Asset Mgt.*, 242 F.3d 325 (5th Cir. 2001) (equitable distribution of invested funds, pro rata, according to net cash losses of the investors). As discussed by the Second Circuit in the *Credit Bancorp* case, this treatment is consistent with the common law principle that a constructive trust arises in favor of a defrauded party. *Credit Bancorp*, 290 F.3d at 88-89. Such

trust assets are not, however, available to satisfy general creditors of the defendant in receivership. The priority established for beneficiaries of a constructive trust gives “the party injured by the unlawful diversion a priority of right over the other creditors of the possessor.” III CLARK ON RECEIVERS § 662.1, at 1174 (Anderson 3d ed. 1959) (quoting authorities).

12. Finally, a receivership operates on the basis of this Court’s equitable power. Sitting in equity, this Court is a “court of conscience.” *Wilson v. Wall*, 73 U.S. 83, 90 (1867). As such, this Court has the power in equity “to do what is right under the circumstances.” *U.S. v. Durham*, 86 F.3d 70, 73 (5th Cir. 1996) (affirming exercise of district court’s discretion with respect to constructive trusts sought to be imposed).

Relief Sought

13. Wherefore, the Receiver and the Bristlewood Claimants pray that the Court approve the agreed claim determination consistent with the Claim Stipulation and Agreement tendered herewith as Exhibit 1.

CLAIM STIPULATION AND AGREEMENT

The following stipulations and agreements (“Agreement”) are entered into this ___ day of September, 2012 (“Effective Date”), by and between Keith M. Aurzada as Receiver for James G. Temme, Stewardship Fund, LP and all other entities directly or indirectly controlled by James G. Temme or Stewardship Fund, LP (“Receiver”) and Bristlewood, LP (“Bristlewood”), Stewardship Fund No. 2, LP, Stewardship Fund No. 3, LP, Stewardship Fund No. 4, LP, Stewardship Fund No. 5, LP, Stewardship Fund No. 6, LP, Stewardship Fund No. 7, LP (“Stewardship Fund Limited Partnerships”), Canadian Peso 21, Klipspringer Partners LP, Kennywood Partners, Ltd., J. Christopher Dance, Leslie T. Merrick Investment Trust, The Kenny Allen Troutt Descendants Trust, Canadian Peso 25, and Canadian Peso 27 (“Limited Partnership Members”) (collectively “Bristlewood Claimants”).

WHEREAS, on October 14, 2011, the Securities and Exchange Commission instituted Civil Action No. 4:11-cv-655, *Securities and Exchange Commission v. Temme and Stewardship Fund, LP*, in the United States District Court for the Eastern District of Texas, Sherman Division (“Court”) (“SEC Action”); and

WHEREAS, on October 28, 2011, the Court appointed the Receiver pursuant to various Court Orders therein (including Docs. 24, 25, and 30) for the Receivership Estate (as defined in the Court Orders); and

WHEREAS, on or about February 27, 2012, the Bristlewood Claimants submitted a claim using the form approved by the Court for victims of the fraudulent acts made the basis of the SEC Action (“Bristlewood Claim”); and

WHEREAS, the Receiver has had an opportunity to review the Bristlewood Claim and the materials submitted therewith; and

WHEREAS, the Receiver has determined that the Bristlewood Claim should be adjusted and approved as set forth in this stipulation; and

WHEREAS, the Bristlewood Claimants have considered the Receiver's determination and have agreed to compromise their claim as set forth in this stipulation; and

WHEREAS, the Parties believe that it is appropriate to obtain Court approval of the resolution of the Bristlewood Claim in order to allow the Receiver to proceed with an orderly administration of the Receivership Estate and in order to allow the Parties to continue to maximize the value of their respective interests in the Stewardship Fund Limited Partnerships;

NOW THEREFORE, in consideration of the mutual promises contained herein and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Parties stipulate and agree to the following:

1. Approved Claim Amount

The Parties hereby stipulate to an approved claim amount of \$7,619,116.21 (the "Approved Claim Amount"). The Approved Claim Amount is based upon an aggregate net cash loss of \$9,137,715.75, as reduced by agreement to reflect any and all potential offsets. The Parties further stipulate that, accordingly, the Bristlewood Claimants shall be entitled to receive, without offset, a pro-rata share, based upon the Approved Claim Amount, of any assets of the Receivership Estate that may be approved for distribution to victims of the fraudulent acts made the basis of the SEC Action.

2. Payment of Claim to Bristlewood

The Bristlewood Claimants represent that they have agreed among themselves that any payment made on the basis of the Bristlewood Claim shall be made to Bristlewood, and the Receiver acknowledges such agreement and agrees to make payment with regard to the Bristlewood Claim to Bristlewood.

3. Stewardship Fund Limited Partnerships

a. Priority of Distributions - The operation of each Stewardship Fund Limited Partnership and income, if any, derived therefrom, shall continue to be governed by the respective limited partnership agreements (each, a "Partnership Agreement") and that

certain Letter Agreement, dated September 30, 2010, between Stewardship Fund, LP and certain Limited Partnership Members (the "Letter Agreement"). The Bristlewood Claimants acknowledge that the Receiver, through Stewardship Fund, LP, holds a 40% profits interest in each of the Stewardship Fund Limited Partnerships.¹ The Receiver acknowledges that such interests are subject to a clawback agreement set forth in the Letter Agreement, such that the Limited Partnership Members, through Bristlewood, are, as of the Effective Date, generally entitled to receive aggregate distributions equal to their invested capital before the Receiver, through Stewardship Fund, LP, will become entitled to share in any distributions.

b. Limited Partnership Assets - The Parties agree that the Stewardship Fund Limited Partnerships hold equitable and/or legal title to the assets identified on Exhibit "A" hereto ("Limited Partnership Assets") and any proceeds therefrom.² The Parties agree to cooperate in maximizing the value of the Limited Partnership Assets for the benefit of the Stewardship Fund Limited Partnerships. In this regard, the Receiver agrees to execute such documents as may be necessary to establish legal title to the Limited Partnership Assets in favor of the Stewardship Fund Limited Partnerships, and the Stewardship Fund Limited Partnerships agree to pay the Receiver's reasonable and necessary attorneys' fees incurred in so doing.

¹ Pursuant to Section 4.9.1 of each Partnership Agreement, Stewardship Fund, LP is entitled to receive 40% of the distributions on Performing Loans (as defined in the Partnership Agreement). Upon liquidation of each Stewardship Fund Limited Partnership, the amount distributed to Stewardship Fund, LP shall not be less than Stewardship Fund, LP would have received if it held a 10% Sharing Ratio (as defined in the Partnership Agreement). Notwithstanding the foregoing, pursuant to Section 6.4 of each Partnership Agreement, Stewardship Fund, LP shall generally not receive any distributions until all record owners of partnership interests (i.e., the Limited Partnership Members) have received distributions equal to their unreturned capital contributions.

²In this regard, the Receiver is presently holding in escrow \$45,100 in proceeds with regard to one such property, which shall be turned over to the Stewardship Fund Limited Partnerships upon Court approval hereof.

4. Asset Disposition Agreement

Nothing in this Agreement shall alter or affect the operation of the Asset Disposition Agreement approved by the Court by order dated March 5, 2012 (Dkt. 63).

5. Resolution of All Claims

Except as expressly preserved or provided herein, the Bristlewood Claimants hereby release and forever discharge the Receiver and the Receivership Estate, including its agents, attorneys, successors, and assigns, from any and all actions, causes of action, suits, claims and demands of whatever kind or character, in law or in equity, whether known or unknown, that occurred prior to the Effective Date.

Except as expressly preserved or provided herein, the Receiver, on behalf of the Receivership Estate, hereby releases, acquits and forever discharges the Bristlewood Claimants and their affiliates, employees, partners, trustees, agents, members, officers, directors, insurers, advisors, including legal counsel, from any and all actions, causes of action, claims or demands, liabilities, losses, damages, attorneys' fees, court costs, or any other form of claim or compensation for known and unknown acts that occurred prior to the Effective Date.

6. Court Approval

The terms hereof shall constitute a joint stipulation to the entry of an order approving the Bristlewood Claim and the agreements set forth herein. However, unless and until the Court approves this Agreement, the terms hereof shall have no force or effect. If approved by the Court, this agreement shall be effective as of the Effective Date.

7. No Admissions

The Parties understand and acknowledge that this Agreement constitutes, at least in part, a compromise of disputable matters. Therefore, neither this Agreement, nor its provisions nor any party's performance of any of the terms hereof shall constitute, or be deemed to constitute, an admission in favor of any third party.

8. Governing Law

The agreements herein shall be governed by and interpreted pursuant to the laws of the State of Texas. Venue of any dispute regarding this Agreement shall lie solely and exclusively in the United States District Court for the Eastern District of Texas as a matter ancillary to the SEC Action.

9. Modifications

This Agreement shall not be modified, amended or superseded except by an instrument in writing signed by all of the Parties.

10. Counterparts

The Parties may execute this Agreement in multiple counterparts, each of which shall be deemed an original, and all of which, when taken together, shall constitute but one and the same instrument. An electronic copy of an originally-signed signature page shall serve as, and constitute, an originally-executed copy of such signature page.
