AGREED MOTION TO EXTEND TIME

Plaintiff Securities and Exchange Commission (“SEC”) and Defendant James G. Temme (“Temme”) respectfully request that the Court extend the deadlines for a response and reply regarding Plaintiff’s Motion for Summary Judgment and Brief in Support Thereof (Doc. 194) (hereafter “the Motion”). The Motion was filed on June 5, 2013 and served via the Court’s CM/ECF system. Accordingly a response is due to be filed on June 24, 2013 and a reply thereto on July 5, 2013 pursuant to local rule (assuming all papers are filed on the deadline).

In light of scheduling, case, and travel conflicts, the SEC has agreed to not oppose Temme’s request to extend Temme’s deadline to respond to the Motion to July 11. In return, to accommodate conflicts that would result from extending the briefing schedule, if Temme’s request for an extension is granted, Temme has agreed that any reply brief should be due on or before August 9. These requested extensions are not for the purpose of delay, but so that justice may be done. Good cause exists for the requested extensions.

Accordingly, the parties respectfully request that the Court modify the briefing deadlines and order that:

1. Defendant Temme's response to the Motion shall be filed on or before July 11, 2013
2. Any reply brief by the SEC re the Motion shall be filed on or before August 9, 2013.

The deadline for filing a sur-reply, if any, is not affected by this motion and would proceed under local rule following the filing of any reply brief.
