The Reply was filed on August 22, 2013 and served via the Court’s CM/ECF system. The Surreply was originally due on September 3, 2013, but it was extended to September 10, 2013.

2. Reply regarding Plaintiff’s Response In Opposition re Opposed Motion to Seal (Doc. 236) (hereafter “the Response to Motion to Seal”). The Response to Motion to Seal was filed on August 22, 2013 and served via the Court’s CM/ECF system. The Reply was originally due on September 3, 2013, but it was extended to September 10, 2013.
