**NOTICE OF SERVICE OF MOTION FOR AUTHORITY TO: (i) ASSIGN LEASE; (ii) SELL REAL PROPERTY; (iii) APPROVE SALES PROCEDURES; AND (iv) ENTER INTO LISTING AGREEMENT AND REQUEST FOR SERVICE BY PUBLICATION**

COMES NOW, Keith M. Aurzada, as Receiver in the above-captioned matter (the “Receiver”) for James G. Temme (“Temme”), Stewardship Fund, LP, and all other entities directly or indirectly controlled by Temme or Stewardship Fund, LP, including, but not limited to Stewardship Advisors, LLC, d/b/a Stewardship Advisors, LP, Stewardship Asset Management Genpar I, LLC, Stewardship Group, LLC, Destiny Fund, LP, and Stewardship Management, LP (collectively, the “Receivership Entities”), and submits this Notice of Service of Motion for Authority to: (i) Assign Lease; (ii) Sell Real Property; (iii) Approve Sales Procedures; and (iv) Enter into Listing Agreement and Request for Service by Publication (the “Motion”).

1. On August 19, 2013, the Receiver filed the Motion seeking Court authorization to market and sell personal and real property commonly known as 8700 Lake Drive, Bonham, Texas 75418 (the “Lake House”).<sup>1</sup>

2. In the Motion, the Receiver represented that, despite a diligent search, he could

not locate the “B and B Family Trust,” a party that may own an interest in the Lake House. Accordingly, the Receiver sought authorization to serve the Motion by publication. Specifically, the Receiver represented that he would publishing a notice in the Fannin County Leader—the newspaper of record for Fannin County (the county in which the Lake House is located)—for three (3) consecutive weeks.

3. By this Notice, the Receiver notifies the Court that he has published a notice of the sale of the Lake House in the Fannin County Leader for three consecutive weeks. Attached hereto as Exhibit A is a true and correct copy of the Affidavit of Publication and excerpts from the editions of the Fannin County Leader containing the Notice.
