**STEWARDSHIP RECEIVERSHIP CLAIMANTS ASSOCIATION’S MOTION FOR
LEAVE TO EXCEED PAGE LIMITATIONS IN ITS SUR-REPLY IN SUPPORT
OF ITS RESPONSE IN OPPOSITION AND OBJECTIONS TO THE RECEIVER’S MOTION
TO APPROVE SETTLEMENT AGREEMENT WITH HALO COMPANIES, INC.**

COMES NOW, Stewardship Receivership Claimants Association (the “Association”), files its Motion for Leave to Exceed Page Limitations in its Sur-Reply in Support of its Response in Opposition and Objections to the Receiver’s Motion to Approve Settlement Agreement with Halo Companies, Inc. (the “Sur-Reply”) and respectfully states as follows:

1. The Receiver’s Reply, which has been filed with the Court totals nineteen (19) pages. The Association intends to file its Sur-Reply to address the many issues raised by the Receiver in his Reply.

2. To adequately reply to the issues raised in the Receiver’s Reply, the Association respectfully requests that it be granted leave to exceed the page limitations of Local Rule 7 and be permitted to file its Sur-Reply totaling no more than ten (10) pages.

3. The Association's counsel has conferred with the Receiver's counsel, who has indicated the Receiver does not oppose the requested page limit extension. Additionally, Receiver's counsel noted in his request for an extension of page limits for his Reply that he would not oppose such an extension for respondents' briefing. *See* [Doc. 270].

4. Accordingly, the Association requests leave of Court to file its Sur-Reply totaling no more than ten (10) pages.
