**UNOPPOSED MOTION FOR SECOND EXTENSION OF TIME FOR STEWARDSHIP  
RECEIVERSHIP CLAIMANTS ASSOCIATION TO FILE OBJECTIONS TO U. S.  
MAGISTRATE JUDGE'S REPORT AND RECOMMENDATION ON THE MOTION TO  
APPROVE SETTLEMENT AGREEMENT WITH HALO COMPANIES, INC.**

TO THE HONORABLE UNITED STATES DISTRICT JUDGE:

Stewardship Receivership Claimants Association (the "Association") files this Unopposed Motion for Second Extension of Time to File Objections to the United States Magistrate Judge's Report and Recommendation on the Motion to Approve Settlement Agreement with Halo Companies, Inc. [Doc. 290] (the "Recommendation") as follows:

**Relief Requested**

1. The Association seeks a 60-day extension of the deadline to file objections to the Recommendation **to and including February 18, 2014**. Neither the SEC nor the Receiver oppose to the extension. This is the second extension sought by the Association, which is sought for good cause (as explained below) and not solely for purposes of delay.

**Basis for Motion**

2. United States Magistrate Judge Amos L. Mazzant filed his Recommendation on November 4, 2013 [Doc. 290]. The Association sought an extension of time to respond because it was in discussions with the SEC and Receiver regarding issues covered by the Recommendation [Doc. 296]. The Court granted an extension until December 20, 2013 [Doc. 298].

3. Since receiving the extension, representatives from the Association have continued discussions with the SEC and the Receiver regarding the proposed Halo settlement. In fact, representatives of the Receiver and representatives of the Association met the day this Motion is filed and had a productive session regarding issues related to the proposed settlement. They hope to continue discussions and reach a mutually acceptable resolution regarding their current disagreements.

4. In light of these continued discussions, and taking into account the intervening holidays, the Association seeks an additional extension of sixty (60) days in order to continue these discussions and still have adequate opportunity to prepare and file objections to the Recommendations if no resolution can be reached.

5. Therefore, the Association requests an extension to prepare and file objections to the Recommendation, if necessary, to and including February 18, 2013.

6. Counsel for the Association has conferred with counsel for the SEC and the Receiver, who have each stated that they are not opposed to this request for a 60-day extension.

7. This request is made so that justice may be done and not solely for the purpose of delay.

BASED ON THE FOREGOING, Stewardship Receivership Claimants Association prays that the Court grant this Unopposed Motion for Second Extension of Time to File Objections to the United States Magistrate Judge's Report and Recommendation on the Motion to Approve Settlement Agreement with Halo Companies, Inc. and for further relief to which it may be justly entitled.
