**ORDER DIRECTING RELEASE OF FUNDS DEPOSITED INTO COURT REGISTRY**

Came for consideration the Receiver’s Motion for Authority to Sell Real and Personal Property and to Approve Sales Procedures and Motion to Release Funds Deposited into Court Registry (the “Motion”) filed by Keith M. Aurzada as receiver (the “Receiver”) for James G. Temme, Stewardship Fund, LP, and all other entities directly or indirectly controlled by James G. Temme or Stewardship Fund, LP, including, but not limited to, Stewardship Advisors, LLC, d/b/a Stewardship Advisors, LP, Stewardship Asset Management Genpar I, LLC, Stewardship Group, LLC, Destiny Fund, LP, and Stewardship Management, LP (collectively, the “Defendants”). Such Motion was GRANTED by the Order Granting the Receiver’s Motion for Authority to Sell Real and Personal Property and to Approve Sales Procedures and Motion to Release Funds Deposited into Court Registry (the “Order”) [Doc. #252]. In its Order, the court stated that if Torok was the highest bidder, the court would instruct the Clerk of the Court to release the \$450,000 to the Receiver, and if Torok was not the highest bidder, the court would instruct the Clerk of the Court to release the \$450,000 to Torok [Doc. #252 at 2, ¶ 11].

Pursuant to the Order, on November 21, 2013, the Receiver filed a Notice of Sale of Real and Personal Property of the Estate and Notice to Release Funds Deposited Into Court Registry (the "Notice") [Doc. #297]. The Notice confirms that Torok was the highest and only bidder at the auction held by the Receiver on October 15, 2013, at Federal Building, 101 East Pecan Street, Room 216, Sherman, Texas 75090, from 9:00 am until 12:00 pm CST.

Based on the Motion [Doc. #233], the Order [Doc. #252], and the Notice [Doc. #297], it is therefore **ORDERED** that the Clerk of the United States District Court for the Eastern District of Texas release the \$450,000 held in the Registry of the Court to the Receiver, Keith M. Aurzada, as soon as practicable.
